Once the CNA has documented the ADL, whether through paper or electronic documentation, the nurse assessment coordinator (NAC) must look at all of the ADL information gathered across all shifts for that seven-day look-back period in order to code the MDS. Section G on the MDS requires coding ADLs that have occurred three or more times.

You may know these documents as “ADL” or “CNA” charts or graphs. It is important that the information on those forms is complete. Each day you provide care to a patient, you need to complete the record for the care you provided. There should be an entry for every blank on the form.

Documentation For CNA

To code an ADL as extensive assistance, you must provide weight bearing assistance for the resident. Examples include: lifting the residents hand to place on a repositioning bar, lifting a residents hand to their mouth while eating or lifting a residents legs into bed.

The resident can perform the ADL on his or her own without help from a CNA. For example, a resident performs her own transfers, such as moving from the bed to the chair, and does not need caregiver help or supervision. – 1 (supervision). Use this code if the resident needs supervi- sion, encouragement, or cuing.

Answer: This results in the coding of a '1, 1,' because the resident only needed supervision for ADL self-performance and set-up help only for ADL support provided, said Wilhide. Handing a resident a walker or locking wheels on a wheelchair does not count in the self-performance category, Shephard added.
