Procedure for change in bank account signatory of a company

A covering letter to the bank manager has to be written for change in authorised signatory along with enclosing therewith a certified true copy of the resolution and other important documents as required by the bank viz. KYC forms duly filled in and signed, identity & address proofs of the signatories, specimen signatures, etc.

Board Resolution Change in Bank Account Authorised Signatory

1. The above changes are applicable only for Authorised Signatories (person(s) authorised to sign or accept cheques and any other instruments) of the account. Any amendment to the list of Authorised Persons shall only be made by amending resolutions duly passed or otherwise in accordance with your Board Resolution. 2.

Documents Checklist for Business Account Update Form

Covering letter to bank for change in authorised signatory is a letter to the banker of the company requesting the bank to change (either add or remove) the list of signatories and their limits who are authorised to operate the account of the company maintained in that bank. • Print the covering letter in the letterhead of the company;
